## **Bath Preservation Trust News**

The Whole Story project has begun! Residents will be aware that work on No 1A Royal Crescent has started, funded by the Brownsword Charitable Foundation, and already is it possible to glimpse the restoration of the venetian windows on the Upper Church Street façade which will do so much to improve the approach to the Royal Crescent.



The Trust has also been working hard on developing its own programme of works at No 1 which will take over when the 1A capital works are complete. Residents should be aware that No 1 will close to visitors in the early autumn this year and be closed well into spring next year, so this year constitutes your 'last chance to see' before the reconfigured attraction opens in 2013. Fridays are free for Discovery Card holders and of course every day is free for Bath Preservation Trust individual members. There is still a considerable funding gap on the

Trust's part of the project and we have a number of attractive funding packages for potential funders. Please contact Claire Owen at the Trust ([cowen@bptrust.org.uk](mailto:cowen@bptrust.org.uk)) if you would like to know more or can help in any way.

Events to the Royal Crescent include World Heritage Day, which will be celebrated again below the Crescent on Sunday 21 April, and we all await further information on the Torch relay event on 22 May. There will also be an attempt in Royal Avenue on the same day to set a record for the number of humans to form the Olympic rings, for which 5000 volunteers are sought.

## **. Waste collection**

Last October I met with Cllr David Dixon, Council cabinet member for Neighbourhoods, to discuss arrangements for waste collection in the Crescent. I again failed to elicit any consideration of resumption of collections from basements, but was pleased to hear that both wheely-bins and fortnightly collections had been rejected. We agreed that when routes are re-organised this year the current arrangements, i.e. waste collection shortly after 7am and recycling collection not long after that, should continue, though the possibility of waste collection between 8pm and midnight the previous evening is also being explored. Empty boxes and bags will be returned to doorways (behind the railings line) to keep the Crescent looking tidy, so please remove them as soon as practicable. Waxed drinks cartons etc. can now be recycled in your blue cardboard bags.

## **Society August Barbecue**

This year's Summer Barbecue, once again kindly hosted, organised and cooked by Tim and Roz Forester at no. 12, is planned for 12 noon on Sunday August 12<sup>th</sup>. Further details will be circulated nearer the time.

## **On Yer Bike!**

This year's Sky Ride is planned for 10am to 3pm on June 3<sup>rd</sup>. Details of the 6 km route are not yet to hand, but the route will probably again include the Royal Crescent, Marlborough Lane, Upper Church Street and Julian Road. We shall be pressing for better alternative parking arrangements than last year. Although there may not be many residents wishing to take part, encouragement of cycling as an alternative to short car journeys should be welcomed if it leads to a reduction in congestion and pollution.

## **Pavement Restoration Project**

Work on the completion of this last phase of the Ha-ha and Railings Restoration is now proceeding. We hope to persuade the Council to turn their attention to the remaining railings in the area, and the road surface, so that the whole area is brought up to a standard befitting its iconic status as one of the jewels in the crown of our World Heritage Site city.

In view of the high cost, and the difficulties envisaged in reaching universal agreement by all freeholders both to contribute to that cost and to allow all the necessary cabling through their properties, it was decided not to proceed. The problem of unsightly aerials is not as great as when the Society tackled this issue many years ago, but it is hoped that any new aerials, or ones being resited, will be positioned out of view from the ground as far as possible.
